


Geary County, KS

- Population
 - 37,030 in 2015
- Median household income lower than KS average
 - \$45,176 compared to 51,872 in Kansas
- More diverse than KS as a whole
 - 69% identifying as white compared to 85% in Kansas
- Younger than Kansas as a whole
 26.4 median age of residents compared to 36 in Kansas



The Data

- 2014 Community Health Assessment and Improvement Plan
 - A lack of available and affordable health food options
 - Access to healthy foods one of three priorities in improvement plan
- Food Desert
 - Four Census tracts in Geary County are consider to be food deserts
- Food insecurity rate
 - Most food insecure county in Kansas with 19.1% of population consider food insecure and 23.9% of children




Live Well Geary County

Formation

• On May 3rd, 2016 Resolution was passed by the City to create a food policy council with the purpose of promoting local food policy to promote access to and consumption of healthly food options in the City of Junction City and Surrounding Geary County

RESOLUTION NO. R-2808

A Resolution Creating a Food Policy Council for the Purpose of Promoting Local Food Policy to Promote Access to and Consumption of Healthy Food Options in the City of Junction City and Surrounding Geary County.

WHEREAS, the City of Junction City actively seeks to improve access to locally grown healthy food options in collaboration with the Live Well Geary County group, and

WHEREAS, the City of Junction City believes that a well-conceived community food policy can dramatically reduce instances of chronic disease and obesity which place undue stress on other community resources, and

WHEREAS, the City of Junction City and outlying areas of Geary County constitute a food desert with limited access to fresh, healthy foods within a reasonable distance, and

WHEREAS, the City of Junction City Commission has made the recruitment of grocery or local food provider a top priority for economic development,

THEREFORE, BE IT RESOLVED, the City Commission of Junction City, Kansas hereby establishes a Food Policy Council. The Food Policy Council shall become effective after passage by the majority of the City Commission and shall continue annually unless terminated by the City Commission.

Members of the Council shall be appointed by the City Commission as necessary. The body of the Food Policy Council shall not exceed 15 members, with member serving staggered two year terms.

The Food Policy Council shall serve as an advisory board and has no authority to take official action on behalf of the City Commission. The Food Policy Council may actively seek grant funding for its activities.

First Things First

- Group scheduled a monthly standing meeting
- Bylaws were created
 - Members are staggered on one and two year terms for the first year
 - Members must be approved by the City Commission
 - Chair, Chair-Elect, and Secretary *Note: no Treasurer
- We knew we needed to assess the community strengths and weaknesses (specifically related to the food system) before we could suggest changes and start working towards our goals

- 2. Secondary Data- written report
- 3. FEAST event- qualitative data/ "voice of the people"

- FEAST stands for Food,

- Agenda included:

 - Facilitated dialog to address assets, gaps, and priorities
 - Formed three priority work groups
 - Shared Local Meal


